The following information is presented as of December 31, 2010. All capitalized terms in this Schedule B have the same meanings given such terms in the statement to which this Schedule B is a part.

Valhi, NL, Harold C. Simmons, TFMC, Harold C. Simmons' wife and Contran are the direct holders of 50.0%, 30.4%, 0.4%, 0.1%, 0.1% and less than 0.1%, respectively, of the Outstanding Shares. Together, Valhi, NL, TFMC and Contran may be deemed to control the Company.

TIMET is the direct holder of 100% of the outstanding shares of common stock of TFMC and may be deemed to control TFMC. VHC, Harold C. Simmons' wife, the CMRT, Harold C. Simmons, the Company, NL, Valhi, Contran and the Foundation are the holders of approximately 24.9%, 12.1%, 8.6%, 3.1%, 1.5%, 0.8%, 0.5%, 0.4% and less than 0.1%, respectively, of the outstanding shares of common stock of TIMET. NL's percentage ownership of TIMET common stock includes 0.3% directly held by a subsidiary of NL. Together VHC, the Company, NL, Valhi, Contran, Harold C. Simmons and his wife may be deemed to control TIMET.

Valhi, Harold C. Simmons, Harold C. Simmons' wife, TFMC and the Company are the direct holders of approximately 83.0%, 2.1%, 0.6%, 0.5% and less than 0.1%, respectively, of the outstanding shares of NL common stock. Together, Valhi, TFMC and the Company may be deemed to control NL.

VHC, TFMC, the Foundation, the Contran Amended and Restated Deferred Compensation Trust (the "*CDCT*"), Harold C. Simmons, Harold C. Simmons' wife, the CMRT and Contran are the direct holders of 92.4%, 1.3%, 0.9%, 0.3%, 0.2%, 0.1% and less than 0.1%, respectively, of the outstanding shares of common stock of Valhi. Together, VHC, TFMC and Contran may be deemed to control Valhi. Dixie Rice is the direct holder of 100% of the outstanding common stock of VHC and may be deemed to control VHC. Contran is the holder of 100% of the outstanding common stock of Dixie Rice.

Substantially all of Contran's outstanding voting stock is held by trusts established for the benefit of certain children and grandchildren of Harold C. Simmons (the "*Trusts*"), of which Mr. Simmons is the sole trustee, or held by Mr. Simmons or persons or other entities related to Mr. Simmons. As sole trustee of each of the Trusts, Mr. Simmons has the power to vote and direct the disposition of the shares of Contran stock held by each of the Trusts. Mr. Simmons, however, disclaims beneficial ownership of any shares of Contran stock that the Trusts held.

The Foundation directly holds less than 0.1% of the outstanding shares of TIMET common stock and 0.9% of the outstanding shares of Valhi common stock. The Foundation is a tax-exempt foundation organized for charitable purposes. Harold C. Simmons is the chairman of the board of the Foundation and may be deemed to control the Foundation.

The CMRT directly holds approximately 8.6% of the outstanding shares of TIMET common stock and 0.1% of the outstanding shares of Valhi common stock. Contran sponsors the CMRT as a trust to permit the collective investment by master trusts that maintain the assets of certain employee benefit plans Contran and related companies adopt. Mr. Simmons is the sole trustee of the CMRT and a member of the trust investment committee for the CMRT. Mr. Simmons is a participant in one or more of the employee benefit plans that invest through the CMRT.

The CDCT directly holds approximately 0.3% of the outstanding shares of Valhi common stock. U.S. Bank National Association serves as the trustee of the CDCT. Contran established the CDCT as an irrevocable "rabbi trust" to assist Contran in meeting certain deferred compensation obligations that it owes to Harold C. Simmons. If the CDCT assets are insufficient to satisfy such obligations, Contran is obligated to satisfy the balance of such obligations as they come due. Pursuant to the terms of the CDCT, Contran (i) retains the power to vote the shares of Valhi common stock held directly by the CDCT, (ii) retains dispositive power over such shares and (iii) may be deemed the indirect beneficial owner of such shares.

As already discussed, Valhi is the direct holder of approximately 83.0% of the outstanding common stock of NL and 50.0% of the outstanding common stock of the Company and may be deemed to control NL and the Company. NL, a subsidiary of NL and the Company directly own 3,604,790 shares, 1,186,200 shares and 121,273 shares of Valhi common stock, respectively. Pursuant to Delaware law, NL treats the shares of Valhi common stock that NL, its subsidiary and the Company own as treasury stock for voting purposes and for the purposes of percentage calculation in this amendment to Schedule 13G such shares are not deemed outstanding.

Harold C. Simmons is the chairman of the board of each of the Company, Contran, Dixie Rice, TIMET, Valhi and VHC and chairman of the board and chief executive officer of NL.

By virtue of the holding of the offices, the stock ownership and his services as trustee, all as described above, (a) Harold C. Simmons may be deemed to control such entities and (b) Mr. Simmons and certain of such entities may be deemed to possess indirect beneficial ownership of Shares directly held by certain of such other entities. However, Mr. Simmons disclaims such beneficial ownership of the Shares beneficially owned directly or indirectly by any of such entities. Mr. Harold Simmons disclaims beneficial ownership of all Shares that Valhi, NL or TFMC directly hold.

Harold C. Simmons' wife is the direct owner of 54,856 Shares, 292,225 shares of NL common stock, 21,825,875 shares of TIMET common stock and 219,796 shares of Valhi common stock. Mr. Simmons may be deemed to share indirect beneficial ownership of such shares. Mr. Simmons disclaims all such beneficial ownership.

Harold C. Simmons directly holds 258,720 Shares, 1,007,145 shares of NL common stock, 5,628,787 shares of TIMET common stock and 343,183 shares of Valhi common stock.

A trust of which Harold C. Simmons and his wife are co-trustees and the beneficiaries of which are the grandchildren of his wife is the direct holder of 15,432 shares of TIMET common stock and 31,800 shares of Valhi common stock. Mr. Simmons disclaims beneficial ownership of these shares.
